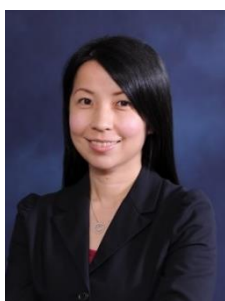

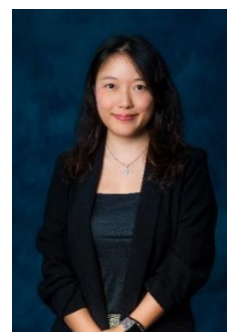


Ms. Icy WONG
